- *Since April 2013, the KAPK is a full member of ENQA (European Association for Quality Assurance in Higher Education)*
- *Since November 2014 KAPK is registered in EQAR (European Quality Assurance Register for Higher Education)*
- *The study program that is accredited in the Republic of Serbia is recognized in most European countries (signatories of ENQA) and does not have to be re-accredited if they are performed in these countries*

- *Creating a self-evaluation report, through the set of 14 standards prescribed in the **ORDINANCE ON STANDARDS FOR SELF-EVALUATION AND ASSESSMENT OF THE QUALITY OF HIGHER EDUCATION INSTITUTIONS** ("Off. Gazette of RS", no. 106/2006)*
- ***EXTERNAL QUALITY ASSESSMENT** by the Sub-Commission of KAPK in accordance with 9 standards prescribed in the **THE ORDINANCE OF STANDARDS AND PROCEDURES FOR OUTSIDE QUALITY EVALUATION OF HIGHER EDUCATION INSTITUTIONS** ("Off. Gazette of RS", no. 106/2006, 73/2011, 101/2012, 103/2012 - ispr. i 13/2014)*

PROCEDURE OF ACCREDITATION - ACTIVITIES :

- *Preparation of documentation for the accreditation of Institution (13 standards) and for each study program at the first and second level of studies (12 standards) / doctoral studies (1 + 11 standards) / doctoral studies of art (1 + 12 standards), in accordance with the **REGULATION ON STANDARDS AND PROCEDURE FOR ACCREDITATION OF HIGHER EDUCATION INSTITUTIONS AND STUDY PROGRAMS** ("Off. Gazette of RS", no. 106/2006, 112/2008, 70/2011, 101/2012, 13/2014, 111/2015 and 86/2016)*

Accreditation

- *Accreditation / reaccreditation is done every 5 years (according to the proposal of the new law, 7 years),*
- *Based on the accreditation of institutions and study programs work permit is obtained (Ministry or Secretariat),*
- *Study program is accredited first, and then institution,*
- *Study program of undergraduate studies must have at least 180 ECTS in total or 60 ECTS per academic year,*
- *Number of active teaching classes in one week is at least 20 and no more than 30 hours - 26 hours is recommended,*
- *Number of exercise classes must be equal to or less than the number of hours of lectures*

Accreditation subjects are:

- *Higher education institutions (university / faculty – AS Higher education institutions of professional studies – SS)*
- *Study programs at all levels of studies*

Key parameters of accreditation

- *Teaching staff – competencies*
- *Available equipment*
- *Available space*
- *The similarity with European study programs*

Accreditation

- *It is possible to change the study programs without re-accreditation to a max. of 20% of the total number of ECTS,*
- *Study program is not going to re-accreditation only KAPK is informed,*
- *One study program can be accredited by more then one higher education institution from the country and from abroad,*
- *Study programs are accredited for teaching in Serbian and English language,*

Accreditation

- *Faculty of Technical Sciences in Novi Sad will re-accredit all existing study programs and accredit new ones at the end of 2017,*
- *The deadline for submission of complete documentation is in November 2017,*
- *The preparation of the accreditation of study program of doctoral studies Risk Management and Fire Protection (3 years - 180 ECTS) is underway,*
- *The preparation of re-accreditation of master studies program which will be tailored to the needs of this project is underway.*

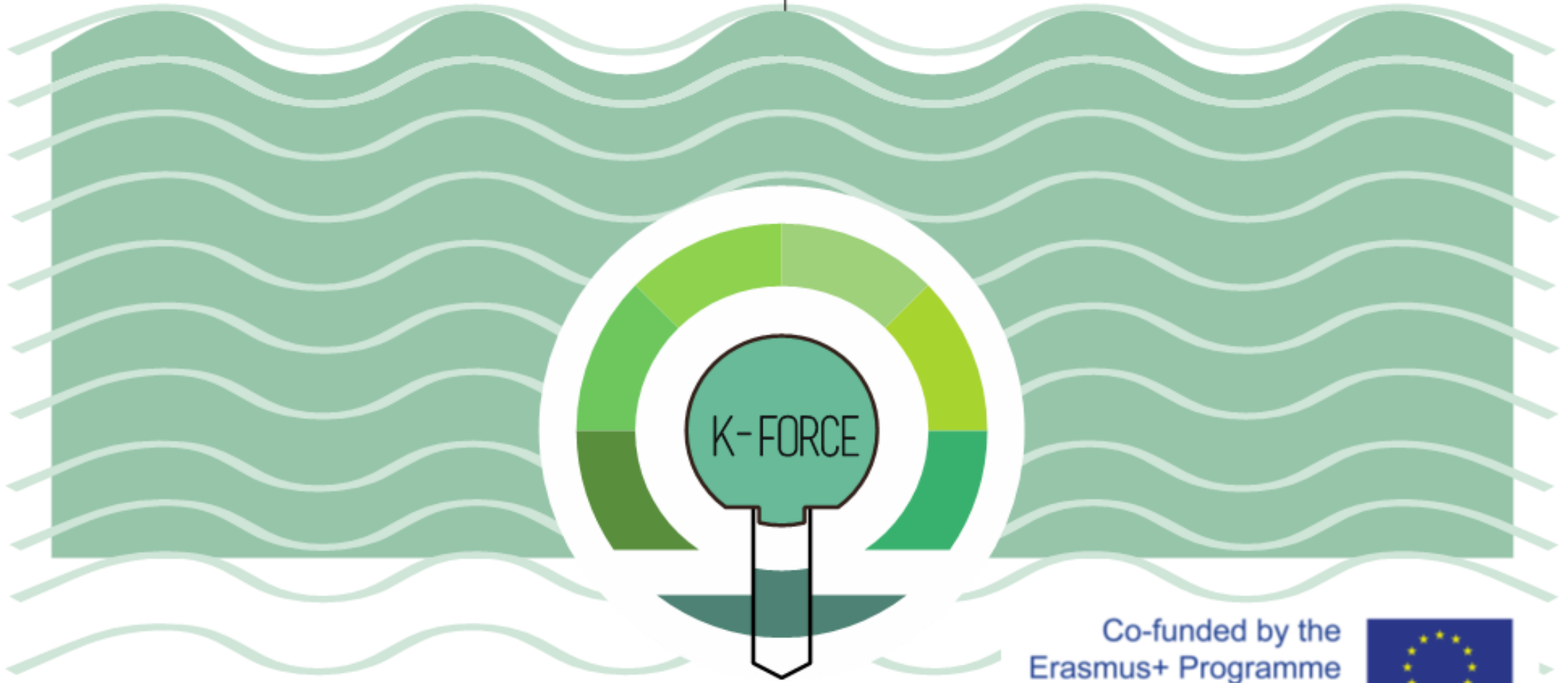
- *In November 2016, Technical College of Professional Studies has submitted documentation for accreditation of:*
