ROLE IN THE PROJECT

- As a project partner, Epoka University role is to modernize the curricula in Disaster Risk Management and Fire Safety Engineering via opening a professional master at the department of Civil engineering, Faculty of Architecture and Engineering in 2018-2019 academic year, according to the regional needs and EU trends.
- Epoka University is responsible to implement certified LLL courses for practitioners in order to insure continuous professional development of employees in DRM&FSE sector.
- In addition, Epoka University role in cooperation with the other projects partners needs to further modernize teaching and training process on different methods including the ICT application.





EXPECTED OUTCOMES AND CONTRIBUTIONS TO OVERALL PROJECT IMPLEMENTATION

- Implementation of an accredited professional Master Program (60 ects) with a Curricula aligned with EU trends and including the installation/activation the equipment
- Improvement of the teaching methodologies including the ICT in learning material. Epoka University teaching staff will be trained on both DRM&FSE topics and b-learning methodologies

The activities implemented by Epoka University are in a high percentage including:

- b. WP3 Improve teaching methodologies and embed the ICT in learning material (e.g. Analyze and agree on the modalities of using ICT for b-learning, Develop b-learning materials for MPs)
- c. WP4 Implementation of Master Programs (Selected MP lectures held by K-FORCE guest lecturers, Ms. Julinda Keci)
- d. WP6 Implementation of LLL courses (Analyze the WBC needs for LLL courses, Adapt selected learning material for LLL courses)
